## **BURNS BOG FIELD TRIP RELEASE AND WAIVER**

As the parent/guardian of the applicant, I hereby grant permission for the below-mentioned child to participate in the Burns Bog Conservation Society's Field Trip Program at the Delta Nature Reserve and represent that she/he is physically able to participate in Field Trip activities. I thereby release the Burns Bog Conservation Society, and its employees from all claims resulting from illness, injuries, or other incidence that may be sustained by the child during attendance on the Field Trip. In the event of illness or injury, I hereby authorize the staff members of the Burns Bog Conservation Society to obtain medical assistance or any other appropriate treatment for the below-mentioned child.

In consideration of the Burns Bog Conservation Society's services, property, and/or equipment, I enable the below-named minor child to participate in outdoor activities and hands-on learning. I agree as follows:

**I UNDERSTAND** that Field Trip activities involve walking through the Delta Nature Reserve in bog lands, handling different plants, removing invasive species, and performing activities in the proximity of native plants, insects, and animals under the supervision of trained tour guides.

**I AGREE** that the student's participation in Field Trip activities is voluntary.

**I AGREE** to release the Burns Bog Conservation Society from all claims for money damages

**I AGREE** to release the Burns Bog Conservation Society from all unintended harm to my child resulting from Field Trip activities.

**I UNDERSTAND** that the Burns Bog Conservation Society encompasses all of their officials, officers, directors, members, employees, agents, personnel, volunteers, sponsors, and affiliated organizations.

**I DECLARE** that am a parents or legal guardian of a minor and I consent to the child's participation and **AGREE** to all of the provisions and to assume all of the obligations of this Release on the child's behalf.

(Check yes if you agree) **I AGREE** that the Burns Bog Conservation Society may document my child's participation in this event on video or by photograph. I grant the Burns Bog Conservation Society's use of any such recordings for promotional materials **ONLY** and will by no means be sold to third parties for monetary benefit to the Society. Such recordings are the sole property of the Burns Bog Conservation Society.

BY SIGNING BELOW I forever release and discharge the Burns Bog Conservation Society, all their employees, all their members and managers, and the staff of this Field Trip for any liability that may occur during my child's visit. For themselves and their family, the undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements, or inducements apart from the forgoing written agreement have been made.
